Interview with Outgoing GGPA President Sylvia Redic

In addition to serving as Grants Administrator for the City of Morrow, GGPA President Sylvia Redic oversees special projects and social media. Most recently, she has stepped up to serve as Interim City Clerk. We asked a few questions of Sylvia as she is preparing to finalize her term as GGPA President:

How long have you been working for the City of Morrow?

12 years.

What brought you into that job?

I applied for work as a 911 Operator because I was finishing my Master's degree in Criminal Justice and wanted to move to the Southside close to my parents. I took the job and lasted nine months (I am not a 911 Operator, that job is difficult!). I applied for an internal position as the

Grants Administrator and the rest is history.

Who are your biggest funders?

The Georgia Department of Transportation and the U.S. Department of Justice consistently are the two biggest funders.

What are the most challenging things about your job?

We are a small city and as in most small cities, you do not get to focus on one area; each position has to cover a lot of ground. It's very rewarding to have the opportunity to be involved in so many facets, but it is challenging because I don't get the opportunity to dwell on things as much as I would like.

What are the most satisfying things about your job?

I am involved with everyone, from the citizens to the developers, from the Mayor and Council to part-time employees. As a veteran of Morrow, I have amassed a great deal of working knowledge and I find I can benefit the city in many ways with my skill set.

Tell us a success story about how you obtained funding.

I am most proud of our pedestrian path system. The system is being installed in phases and takes years and years of planning, applying, project management, and process, but what you have in the end – the contributions you make for the community – those are special. I love taking a walk on the path my work helped put in, taking my son on the walk and telling him that the late nights I worked mean something to this place. That is a true pay-off, when my own son and his friends and the citizens can walk their dogs, take a run, stroll their babies, and just enjoy the outdoors because I got it right.

What advice would you give for someone who would like to do what you do?

Pay attention, pass out business cards, make connections – it is amazing how a brief encounter can help you down the road.

What are the gains you get from being in GGPA and the national Grant Professional Association?

Respect, plain and simple.

Congress Passes FY2014 Omnibus Appropriations Bill

Congress Passes FY 2014 Omnibus Appropriations Bill; Let your representatives know how cuts impact community. The U.S. Senate passed by a vote of 72 to 26 the [FY 2014 omnibus appropriations bill](#), H.R. 3547. The House approved the same bill on January 15th, 359 to 67. The President signed the bill which adheres to the \$1.012 trillion discretionary spending limit agreed to in the Bipartisan Budget Act of 2013. The omnibus, which includes all 12 appropriations bills, sets final FY 2014 appropriations levels and funds all federally funded agencies, through the end of FY 2014 (September 30, 2014).

National Council of State Housing Agencies (NCSHA) is a nonprofit, nonpartisan organization created by the nation's state Housing Finance Agencies (HFAs) more than 30 years ago to coordinate and leverage their federal advocacy efforts for affordable housing. View NCSHA's [budget chart](#), which shows how HUD and USDA program funding levels in the omnibus compare to FY 2013 appropriations, the President's FY 2014 Budget proposal, and the FY 2014 Senate and House-proposed funding levels, for additional information.
